## Key Dates:

Submissions: Till 31 October 2023  
Jury's meeting: November 2023  
Announcement of the winners: December 2023

## Eligibility:

The contest is open to all employees, regardless of nationality.

## Categories:

- Projects: Photos with a project as the main element.
- People, Offices, and Events: Photos of celebrations, special moments, or other situations where people or the festivity are the protagonists.
- Renewable Energy: Photos of Renewable Energy in general.

## Selection Criteria:

The jury will select the best photos based on their content, creativity, aesthetics, and technique demonstrated by the author.

## Format and Requirements:

Submitted photographs must meet the following requirements:

All entries must be high-resolution digital images.

Format: JPEG, PDF, or PNG

Minimum resolution: 1030 x 700 px

## Participation Rules:

- Entries must be the original work of the contestant.
- Entries must have been taken between October 2022 and October 2023.
- Images should also be identified (name of project / people) and dated.
- Prizes will be paid in local currency, at the exchange rate in force on 10.28.2023, by bank transfer. The winner will be asked to provide the IBAN to the email [pagamentos@cjr-group.com](mailto:pagamentos@cjr-group.com).

- **What are the candidates that can participate in the contest?**
